New Jersey Legislature Continues Review of Governor Murphy's Proposed Fiscal Year 2025 Budget

State Senators and members of the General Assembly have been holding their annual budget hearings during April and May. Each Executive Branch agency testifies before the Budget Committees during this annual review process. NJDOT Commissioner Fran O'Connor testified before the Senate Budget Committee on April 11 and the Assembly Budget Committee on April 15. NJAPA Webinar on Best Practices for Porous Pavements Draws Large Crowd

NJAPA presented a webinar recently on Best Practices for Porous Pavements. The program was delivered by Travis Walbeck, P.E., Training Director at the National Center for Asphalt Technology (NCAT) and Dr. Ben Bowers, PhD. P.E., Assistant Professor of Civil Engineering at Auburn University, also affiliated with NCAT.

More than 90 attendees including representatives from State Agencies, County and Municipal

Government, Consulting Engineering firms, contractors and asphalt producers attended the training. Continuing Professional Competency credits were provided as NJAPA is an authorized provider of Continuing Education for the New Jersey State Board of Professional Engineers and Planners.

Attendees learned about mix design, structural design, appropriate uses, maintenance requirements and environmental benefits of porous asphalt.

NJDOT Continues to Bid and Award Work as End of Fiscal Year Approaches

NJDOT continues their efforts to bid and award projects consistent with the Fiscal Year 2024 Capital Program and the annual paving program as presented to the Association at the beginning of the year.

As of May 7, 2024 NJDOT has awarded 74 projects with a contract value of more than \$850 million which includes 30 paving projects valued at \$312 million. Asphalt tonnage awarded thus far is approximately 725,000 tons with more than 190,000 tons currently advertised.
